**SUBMITTAL REQUIREMENTS
For
ROOM ADDITIONS**

Omission of any required items circled below will result in refusal of plans for plan check.

If your project has any of the following: DPR Comments, Mitigation Monitoring Report Plans or Conditions of Approval, include (5) booklets or the minimum number of sets equal to the number of departments reviewing your plans with the items below.

1. Submit five (5) complete sets of plans including:
 - A. Plot plan with property line dimensions and location of the building and any other structures including the proposed room addition (see "Sample plot plan" available at front counter).
 - B. Foundation plan
 - C. Floor plan
 - D. Ceiling and roof framing plan
 - E. Electrical plan: (Electrical service shall be underground, C.M.C. 15.60) For a new service location contact - Tony Lopez, Edison Planner at 909-930-8515 or Lyle Trend at 909-930-8435.
 1. Panel location
 2. Lighting and receptacle layout
 3. Circuit schedule and demand load
 - F. Plumbing isometrics:
 1. Water distribution
 2. Waste and venting
 3. Gas distribution
 - G. Provide a mechanical plan:
 1. Location and size of all registers (supply & return)
 2. Size, location, & manufacturers specifications for all equipment.

2. Provide two (2) sets of "wet" stamped and signed Structural Calculations and roof truss calculations.
3. Provide two (2) sets of Title 24 Energy Calculations. Compliance Forms shall appear on the plans.
4. Provide two (2) sets of Soils Reports
5. Provide two (2) sets of Soil Percolation Test for proposed septic systems.
6. Provide water test for newly drilled wells from Riverside County Department of Health.
7. Separate permits are required for Electrical, Plumbing, and Mechanical, Patio covers, Swimming Pools, Fencing, Garden and Retaining walls.
8. Comply with Corona Burglary Ordinance #15.52 (Copies available at front counter).
9. Fees:
 1. Consult with Utilities and Public Works Departments for any additional fees.
 2. Post Fire Inspection: \$920.00
 3. Building Permit/Plan Check Extension: \$95.00 per application
 3. Archive Fees: 8 $\frac{1}{2}$ x 11 \$.28 per sheet
Larger \$1.03 per sheet
10. All contractors and sub-contractors must show proof of State and City licenses and shall comply with Section 3800 of the Labor Code regarding Workers' Compensation. Homeowners performing and/or coordinating their own construction must complete an Owner-Builder Verification form.
