

# Pool and Spa Cover Rebate Program

## Rebate Information/Terms and Conditions

1. Read the program terms and conditions and the guidelines provided with this package.
2. The rebate only applies to **new** pool and/or spa covers and does not cover used or secondhand covers.
3. The rebate amount is up to \$50 for a pool cover and up to \$25 for a spa cover with a total of up to \$75 for both.
4. A list of local Corona pool supply stores is provided for your reference.
5. Once you have purchased your pool and/or spa cover please submit a completed, signed Rebate Request form, a copy of your receipt, and a copy of your current water bill. Please keep a copy for your records.
6. DWP will contact you once your paperwork has been reviewed and approved confirming that a credit is being applied to your water account for the rebate amount.
7. DWP will apply a credit to your water account for the rebate value. A credit is posted to your account within one week. Please allow up to two billing cycles to see the credit applied to your account on your printed bill.

### Eligibility

1. The pool and/or spa cover must be purchased between 7/1/18 and 6/30/19.
2. A Spa is considered 8' x 8'. Anything larger than this will be considered a pool.
3. The property must receive water service from the City of Corona Department of Water and Power (DWP).
4. The Pool/Spa Cover rebate only applies to new pool and/or spa covers.

### Program Terms

1. DWP customers may reapply for a Pool/Spa Cover Rebate every 2 years.
2. The Pool/Spa Cover Rebate only applies to pool and/or spa covers that decrease evaporation, such as solar blankets or mechanical covers.
3. The completed Rebate Request form must be submitted with a copy of your receipt, a copy of your current water bill and a photo of the new cover on your pool and/or spa.
