## Potable Construction Water Meter Procedure

Only applicable for 1-4 single family residential developments and the construction of potable water facilities. The procedure takes approximately 7 business days.

1. Apply for a **Construction Water Meter** permit at City of Corona [eTRAKiT](#)
2. City will review the application and notify the applicant when the permit is ready for payment
3. Pay the permit deposit online via City of Corona [eTRAKiT](#) or in person at the Public Works front counter located at 400 S. Vicentia Ave, Corona, CA 92882. If payment is made online, contact a Utility Engineer to confirm that payment was received.
4. A Construction Water Permit will be issued and sent via email or handed in person
5. For 3-inch construction water meters and backflow devices, the City will install the devices within five (5) working days after the payment has been received. The City will chain and lock down the devices. There will be a \$100 relocation fee for relocation requests.
6. For 4-inch or greater construction water meters and backflow devices, the City will contact the applicant within 3 working days to have the meter pick-up at the City's warehouse
7. The City will read the meter and provide a bill monthly
8. When the devices are ready to be returned, contact Customer Care at (951) 736-2321

## Reclaimed Construction Water Meter Procedure

Applicable for all construction water uses except the construction of potable water facilities. The procedure takes approximately 10 business days.

1. Apply for a **Reclaimed Water Permit** at City of Corona [eTRAKiT](#)
2. Apply for a **Construction Water Meter** permit at City of Corona [eTRAKiT](#)
3. City will provide a user name, password and link for the Site Supervisor to take and online Site Supervisor Training
4. Applicant will email back the training certificate of completion
5. City will prepare a Reclaimed Water Permit and send it via email to be signed electronically by the site supervisor and company official using DocuSign
6. City will email the applicant the signed Reclaimed Water Permit
9. City will notify the applicant when the permit is ready for payment
7. Applicant will pay the permit deposit online via City of Corona [eTRAKiT](#) or in person at the Public Works front counter located at 400 S. Vicentia Ave, Corona, CA 92882. If payment is made online, contact a Utility Engineer to confirm that payment was received
8. A Construction Water Permit will be issued and sent via email or handed in person
10. For 3-inch construction water, the City will install the devices within five (5) working days after the payment has been received. The City will chain and lock down the meter. There will be a \$100 relocation fee for relocation requests.
