Howard Ware was born in Ventura County on January 9, 1895. At the age of 11, Howard and his family moved to Corona, where his uncle was the owner of Corona Lumber. There it was that he met his future wife Irene, who moved into town about a year later. In 1906 Howard's father died and five years later Howard began work for his uncle in the lumber business.

Irene Ware, born Irene Nonhuf on September 19, 1895, moved with her family to Corona in 1907. It was during elementary school that she became acquainted with Howard, and it was soon after that each developed an infatuation for the other. The love affair had to be put on hold, though, while Irene attended the University of Southern California's School of Music. For years thereafter Irene taught piano in Corona. Finally, in 1923, Howard and Irene were married.

Some years after going to work for his uncle, Howard and his brother Frank took over the lumber business as partners. For 47 years, until his retirement in 1958, Howard was involved in this successful enterprise.

Shortly after Howard retired from the lumber business in 1958, he began to collect Corona memorabilia. On top of the many things that Irene and he had naturally collected over the years, he now began to actively pursue collecting for its own sake. When the people of Corona discovered what Howard was up to, he was soon flooded with old artifacts and manuscripts.

For the following 20 plus years, Howard immersed himself in the history of Corona, and his knowledge was often dawn upon by citizens groups who requested him for speaking engagements.

Nearing the end of his life Howard stipulated that upon his death those records which were not needed by the Ware family were to go to the Corona Public Library's Heritage Room. Consequently, when Howard died on December 17, 1980, his last wishes were carried out, and on January 16, 1981, Irene donated the first of what was to be one of the largest manuscript collections in the Heritage Room. Irene Ware died March 12, 1987.
